Table Tennis England is delighted to announce the completion of a key milestone along the Governance Review consultation timeline, the appointment of the Chairman of Independent Review Panel (IRP) and the commencement of the next stage, the appointment of IRP members.

We are now seeking two Table Tennis people to appoint to the IRP and would ask that you both consider this opportunity and circulate to anyone who may be interested and have the necessary skills.

We are now pleased to announce that, following a tender process and interviews, we have appointed Marc Mazzucco (see *biography below*) as the chairman to lead this Independent Review Panel.

We are now are looking for at least two individuals from Table Tennis to join the panel to input to the consultation, collate the findings, advise on table tennis governance matters and finalise recommendations.

Applicants should be experienced and knowledgeable in the workings of table tennis at different levels, understanding the different perspectives involved and be committed to help move table tennis forward as a modernised, efficient, transparent organisation – in line with code of governance requirements.

It is expected that this will require a time commitment of between 10–15 days over the next nine months through a mix of face to face meetings, telephone calls and reviewing material. A nominal fee and costs will be paid.
