Eligibility Criteria	<ul style="list-style-type: none"> • All players must be a Player Member of the ETTA Ltd. • Each Local League is eligible to enter one or more teams in each competition. • Players must have played at least 4 matches in the league represented in the competition during the season in which the competition started and/or the immediately preceding season. • A player cannot play for more than one team in each category. • A junior player having represented a League in Event 3 or 4 shall be eligible to represent another League in Event 1 or 2 provided they meet the necessary criteria above. • A Player Licence is not required.
Structure	8 zones with teams allocated a zone on a geographical basis. Zones may be amalgamated (see Appendix F). Zonal matches and finals to be played in groups or as a knockout at the discretion of the Committee.
Teams	Minimum of 2 players, maximum of 4 players per team. Two players play two singles each and up to two different players may play doubles.
Playing Format	A v Y, B v Z, Doubles, A v Z, B v Y. 5 matches in total. All matches to be played.
Venues	Zonal venues to be fixed by the Committee. Finals to be held at Westfield Table Tennis Club, c/o Weavers Leisure Centre, Weavers Road, Wellingborough, Northants, NN8 3JQ
Dates	Closing Date: All competitions - Monday 3rd March 2014, 5pm. Draw: All competitions – Wednesday 5th March 2014, 5pm. Zonal Matches: Wilmott Cup/J M Rose Bowl – Sunday 13th April 2014. Carter Cup/Bromfield Trophy – Saturday 12th April 2014. Finals: Wilmott Cup/J M Rose Bowl – Saturday 7th June 2014. Carter Cup/Bromfield Trophy – Sunday, 8th June 2014.
Expenses	Zonal Rounds – Pooled (venue, travel, administrative), settlement on the day. Finals: Teams meet own costs.
