TOURNAMENT REGULATIONS (to be retained)

- 1. Every entrant must be affiliated as a Player Member to Table Tennis England or to another National Association in membership of the ITTF.
- 2. Table Tennis England Tournament Regulations apply to this tournament including Regulation R (Racket Re-Rubbering). ITTF Regulations for International Competitions apply except those relating to the matters covered by items marked (x) in this entry form.
- 3. Completion and submission of this Entry Form signifies agreement by the entrant to the conditions of the competition including the variations from the ITTF requirements.
- 4. All competitors may be required to umpire at least one match in each event entered.
- 5. All matches shall be the best of five games. Play throughout will be on a knockout basis with the exception of preliminary rounds which will be on a group basis. The final order in a group shall be determined as per ITTF Regulation 3.7.5. for Group competitions.
- 6. Competitors in Junior events must have been born in 1998 or later. Competitors in Cadet events must have been born in 2001 or later. Competitors in Under 13 events must have been born in 2003 or later. Competitors in Under 11 events must have been born in 2005 or later.
- 7. Doping shall not take place either before or during play.
- 8. No competitor or official shall engage in betting on players or matches.
- 9. All competitors must report to the control on arrival and must not leave the hall without first obtaining permission from the Referee. Players absent when called upon to play are liable to be scratched.
- 10. Should there be insufficient entries in any event the Referee reserves the right to cancel that event/merge such event and/or place the entrant in a similar event.
- 11. Every Entrant must hold a valid Table Tennis England Player Licence or have paid the appropriate Single Tournament Competition Fee with their entry from, unless he/she provides proof of being a member of another National Association affiliated to the ITTF and is not affiliated to Table Tennis England.
- 12. The referee's decision shall be final on points of law, and any question arising not provided for in these regulations, or in any dispute as to the interpretation thereof. Decisions on points of fact by an umpire or assistant umpire appointed by the Referee shall be final.
